ASA Monthly Credit/Debit Card Billing Policy

Initiation of Recurring Payment Option

ASA offers automatic monthly billing directly to a member's American Express, VISA or MasterCard credit or debit card. A member may exercise the recurring payment option by completing ASA's Authorization for Monthly Credit/Debit Card Billing form and returning the form to its ASA chapter. Upon receipt of the authorization, monthly payments will be charged to your card beginning with the current month. On the 1st day of every subsequent month, ASA will debit your credit/debit card with the currently monthly dues charge.

Changing Recurring Payment Option

If you would like to change your Monthly Credit/Debit Card Payment Option including, for example, making a change from one credit/debit card that was initially selected to another credit/debit card, you must authorize the recurring payment with the new credit/debit card by completing a new form. The change will not go into effect until the billing cycle after the new form is received. Your previously approved Monthly Credit/Debit Card Payment Option will be used until the new option goes into effect.

Recurring Payment Failure

If your recurring payment is declined, your Monthly Credit/Debit Payment Option will be removed and ASA will invoice you for the remaining portion of your annual dues. ASA may restrict your ability to use the payment method that was declined (e.g., credit card) for a period of time.

Cancellation of Recurring Payment Option

ASA dues are payable on an annual basis, from July 1 through June 30. Cancellation of this payment option must be made in writing to your ASA chapter or directly to ASA headquarters in Alexandria, Virginia, no later than June 1 to cancel membership for the following fiscal year.
